**1. Apologies for absence**

Apologies were received from Barrie Page, Glyn Smith and Graham White.

**2. Declarations of Interest and Dispensations:** Tracey Dyson for grant application from K-style/AYDMS and Ivor Beynon for the grant application from Ebenezer Baptist Church.

**3. Minutes 26 March 2025.**

The Council **RESOLVED** that the minutes were a true and correct record.

**4. Bank Reconciliation**

The Council **RESOLVED** to accept the bank reconciliations and payments for March 2025.

**5. Council Grant Applications**

**1: Ebenezer Baptist Church –**

There was some concern that Ebenezer Church and its groups had already received over £7,000 of ALCC grants in the last 12 months. A query was raised over an identical application for Council Funding for Chairs in March 2025. It was also confirmed that this application was for a different set of chairs that grant money had been given.

The Council **RESOLVED** to grant Ebenezer Baptist Church £1,000 towards the cost of replacing seating in the coffee bar area. (Local Government (Miscellaneous Provisions) Act 1976 s.19).

## **2: Six Bells Tenants and Residents Association**

The Council **RESOLVED** to grant Six Bells Tenants and Residents Association £1,766 towards the costs of the 65<sup>th</sup> Commemoration of the Six Bells Miners' Disaster Event. (Local Government (Miscellaneous Provisions) Act 1976 s.19).

## **3:K-Style and AYDMS**

## **9. Recommendations from Finance Committee.**

The Chair of the Finance committee, Steve Bard, gave a brief overview of the of the Audit Wales report on the objections to the 2020/21 accounts. A number of the main recommendations they Council have already taken on board since 2021.

The Council **RESOLVED** that the Code of Conduct training should be done every 5 years.

The Council **RESOLVED** that the Staffing Matter be referred to the HR Committee.

## **10. Solar Farm Grant 2025**

The Council **RESOLVED** the following process for the award of the Solare farm Grant in 2025.

- i. May 2025 the grant process would be opened and application forms available
- ii. Organisations will have until the end of July to put in their applications
- iii. The Officers will conduct follow up questions during August

iv. The Council will make its decisions in September.
