#### 94. Minutes 24 September 2025

# 95. Council Grant Application

The grant application from Abertillery Learning Committee was discussed, there was some concern that this could be seen as funding education which is the responsibility of Blaenau Gwent County Borough Council. The Council **RESOLVED** to award a grant of £1,460 to Abertillery Learning Centre (Local Government Act 1972 s.137) but we will pay the invoice direct so it does not go through any school budget.

### 96. Resolution to exclude the press and public

The Council **RESOLVED** that, by virtue of The Public Bodies (Admission to Meetings) Act 1960, the press and public are excluded from discussions on the following items on the basis that disclosure thereof would be prejudicial to the public interest by reason of the confidential nature of the business to be transacted.

## 97. Mural Tenders.

The Council heard representations from the two tender companies. Both had their merits. Council **RESOLVED** to offer the contract to TAFY as they felt the provision of an inspection report and the written confirmation that TAFY could use and store the specific cleaning chemicals outweighed the provision of more frequent inspections by Green Fingers.

There was a brief adjournment of the meeting during the first presentation as the microphone system had failed and had to be fixed

## 98. Resolution to readmit the press and public

Council **RESOLVED** to readmit the press and public.

#### 99. Presentation from Wellbeing Community Wellbeing Hub.

The main points from the presentation were.

- This is a networking service for Community Hubs supporting through Facebook page and registration on an interactive map
- They are looking at places and buildings that have a high footfall
- It is used to signpost services that may be useful for Community Groups
- Working in partnerships with Community Groups
- Already received a list of potential Community Group partners from the Deputy Clerk but encourage Councillors to promote this hub within Community Groups that could benefit.
- There is a pop-up event on 19<sup>th</sup> November, 6:00pm to 8:30pm at Llanhilleth Institute to coincide with International Men's Day, with 20 stalls attending.
- There are currently two Well Being Coaches and the network is looking for a further 2

It was noted by Council that Ebenezer Church and Café Tyleri were already part of the network and St Micheals Church could benefit by joining.

#### 100. Bank reconciliation (July and September)

There was a question concerning the money paid to Cwtch Media, it was explained that they provide a number of services for the Viaduct Run. There was a question concerning the interest paid on the investment account, it was explained that this interest went into General Reserves to help bring them up to the minimum 25% of budget that was recommended in audit guidance

# 101. PlaCE Committee

Council **RESOLVED** to co-opt Richard Catlin as a member of the PlaCE Committee.

## 102. Grants Policy.

Cllr. Steve Bard presented the new Grants Policy.

It was asked if the Officers could monitor the grant spend across the different ward, but the Clerk responded that Councillors had a duty to monitor themselves and it would be difficult to attribute the benefits to individual wards for grants that have been awarded.

Council **RESOLVED** to adopt the new grants policy and all the recommendations within.

### 103. Risk Register

Cllr. Steve Brad presented the Risk Register. He explained that this was different to the Financial Risk Register but there is some crossover of risks. Both are reviewed annually by the Finance and Governance Committee.

The Council **RESOLVED** to agree new Risk Register.

# 104. Solar Farm Underspend

The Council **RESOLVED** that the £3,541.25 underspend from the Roseheyworth Park project should be repaid back to Council. The Officers will bring back to the next Council meeting a number of options to deal with the money.
