Financial report

The Council currently holds a large amount of public money.

Reserves

All community councils should hold reserves to enable them to continue to carry out their functions in the face of unexpected expenditure or a sudden drop in income. The official guidance advises that community councils' reserves should be between 25 percent and 100 percent of a council's annual budget. As Abertillery and Llanhilleth Community Council's income is not reliant on unpredictable investments or uncertain commercial activities, it would be expected to hold reserves near the lower end of the 25-100 percent range. The Council's current reserves are more than £20,000 higher than the 25 percent mark.

Current account

This Council needs to make sure that it can bear a very large bill at the start of each financial year when it pays the annual bills for its two Council-supported youth engagement projects. The Council also needs to carry £40,000-to-£60,000 in its current account at the start of each quarter to enable it to comfortably ride the peaks and troughs of spending throughout the year.

Nevertheless, the Council holds far more money in its current account than it is forecast to require. The figure as of 31 October (£178,010) is forecast to fall to around £163,000 by the end of the financial year, but this will still be more than £60,000 in excess of what the Council is forecast to require.

Budget and expenditure

The Council is compelled to set aside funds in its budget for some items even though it does not believe those funds will be spent. For instance, the Council had to set aside funds to pay for Council elections in May 2022 even though few people expected those elections to be contested. These items mean that the Council is always forecast to spend less than its annual budget.

However, even when those compulsory budget lines are removed from the calculations, this Council is forecast to spend substantially less than it budgeted for in 2022-23. The Council budgeted to spend more than its income in 2022-23 (which would have had the effect of reducing its inflated current account balance) but, in the event, the Council is currently forecast to underspend by more than £70,000.

Budget proposals 2023-24

Even though this Council is forecast to substantially underspend against its budget for the third year in a row in 2022-23, the draft budget proposals submitted by budget-holders for 2023-24 would see the budget rise significantly. When the compulsory budget lines noted above are removed from the calculations, the draft budget for 2023-24 is currently 65 percent higher than the amount this Council is forecast to spend in 2022-23.

This suggests that the Council continues to plan for expenditure that it does not have the wherewithal – in terms of Members' and officers' time and capabilities – to actually carry out.

Co-options



Council Grant criteria and process

The current criteria for the award of Council Grants were drawn up more than five years ago. In practice, the Council has regularly chosen not to follow its own criteria.

There appear to be two main reasons for this:

- The Council expected applications for Council Grants to greatly exceed the available budget. It, therefore, agreed criteria that would limit the number of applicants. In practice, Council Grants have been under-subscribed.
- The upper limit for Council Grants is currently £500, "unless in exceptional circumstances." The lower limit for Solar Farm Grants is £5,000. Unless it ignores its own criteria, the Council has no avenue to award grants in the £500-£5,000 range.

The revised Council Grant criteria and process (below) raise the financial limit for Council Grants and remove or amend some other criteria to better reflect how Council Grant awards have been determined in practice.



Abertillery and Llanhilleth Community Council Revised Council Grant criteria and process

- 1. The purpose of Council Grants is to help local communities and established organisations to improve the well-being of local people. A Council Grant award will only be made if there is a clear economic, social or environmental well-being benefit to residents of the Abertillery and Llanhilleth Community Council area.
- 2. Council Grant awards will not be made to individuals, to individual families or to ad hoc groups unless the applicant can demonstrate a clear economic, social or environmental well-being benefit to the wider community of the Abertillery and Llanhilleth Community Council area.
- 3. The organisation must usually be based in, or operate substantially in, the Abertillery and Llanhilleth Community Council area, and the majority of the members of the organisation, or those it serves, should live in the Abertillery and Llanhilleth Community Council area.
- 4. If the organisation is based outside the Abertillery and Llanhilleth Community Council area, evidence must be given of how (and how many) people from the Abertillery and Llanhilleth Community Council area benefit from the work of the organisation.
- 5. In determining Council Grant awards, the Council shall place a high value on voluntary and community service.
- 6. The Council will not make a grant to professional or commercial clubs or organisations, companies, businesses or other enterprises that aim to make a profit. The Council will make grants only to organisations if they are not-for-profit and if any surplus generated by the enterprise is reinvested into improving local communities or local community facilities.
- 7. Organisations such as sports clubs or parks which have become companies in order to

- manage or run community facilities under Community Asset Transfers may be considered for Council Grants.
- 8. The Council will not award a Council Grant to a national charity, unless they can demonstrate clearly and specifically how that funding will benefit residents and service users in the Abertillery and Llanhilleth Community Council area.
- The Council shall allocate its Council Grants budget according to the principle of benefiting as many people and communities in the Abertillery and Llanhilleth Community Council area as possible.
- 10. Council Grants will not usually be awarded for amounts over £500. In any case, the Council shall not award a Council Grant of more than £5,000 to an applicant.

How does the Council Grants process work?

- 1. All Council Grant applications should be made using the Council Grant application form. The Council may refuse to consider any grant applications that are not made using the required form or that do not contain the required details (e.g. the specific amount requested and the purpose of the grant).
- 2. Council Grant applications may be considered by the Finance and Grants Committee before submission to the Full Council. The Committee may scrutinise the application and make recommendations to the Full Council.
- 3. A representative of the applicant organisation may be required to attend a meeting of the Council or of the Finance and Grants Committee in order to provide more information about the application.
- 4. Any grant award made by the Council should be publicised appropriately by the receiving organisation (e.g., on its website, social media pages and/or posters/programmes).
- 5. The Council may at any time require any and all such evidence as it decides that a Council Grant given previously has been spent in the manner for which it was intended.

Removing this clause would enable the Council to consider any application for 'running costs' on its merits.
Delete: "The Council wishes to spend its limited grants budget to help as many people and communities as possible in the ALCC area. The Council will not therefore give financial support to the same organisation in two consecutive years unless in exceptional circumstances."	The current criteria assume that the Council will be over-subscribed with applications for Council Grants and will need to ration its support. In practice, the Council Grants budget has been under-subscribed for several years.

Delete: "The Council will not give a grant of more than £500 to one organisation unless in exceptional circumstances." Insert: "Council Grants will not usually be awarded for amounts over £500. The Council currently has no provision for grant awards between £500 (the upper limit for Council Grants) and £5,000 (the lower limit for Solar Farm Grants). The current criteria assume that the Council will be over-subscribed with applications for Council Grants and will need the Finance and Grants Committee to sift through them. In practice, the Council Grants budget has been under-subscribed. If a meeting of the Finance and Grants Committee has been scheduled before the next Full Council meeting, it may be helpful for them to look through applications – but making it a requirement that all applications are scrutinised by that committee seems an unnecessary step.
Delete: "The Finance and Grants Committee and the Council will consider grant applications no more than four times a year; intended to be in April, June, November and January. Any applications submitted after a relevant deadline will be held over and not considered until the following meeting." Ward Grant applications

Each Member of the Council may propose Ward Grants up to a total of £200 each year. Although Ward Grant awards must be authorised by either the Finance and Grants Committee or a meeting of the Full Council, they are traditionally agreed to on the recommendation of the proposing Member without debate.

Abertillery Excelsiors Junior FC - Glyn Smith

The club is required to provide all ten of its teams with a first aid kit. The proposed award will provide more than half of the necessary funding.

As well as voluntarily staffing a refreshment kiosk at the park, the Friends of Six Bells Park clean the area, cut the hedges, maintain bird baths and bird feeders, and are responsible for a wealth of planters and extensive floral displays.
