52. Town in Bloom – Tender.

There had only been one tender received, from TAFY. Neil Hirst gave a brief background on TAFY and how they worked toward making young people (mostly young men 16-25) employable by giving them skills and teaching them about Health and Safety.

If successful TAFY would allocate a Horticulturist to lead on our project. They would also work closely with schools in our area.

The Committee asked a number of questions, concerning numbers of vehicles, how things would be managed during school holidays, local buying and using compost from BGCBC.

Neil Hirst was asked to leave the room while the Committee debated the decisions.

The Committee **RESOLVED** to award the five-year contract to TAFY. The Contract to be signed by the Clerk and the Chair of Council on behalf of Council and is based on the tender received.
