A query was asked about the Risk Assessment: If police presence should be encouraged. The Clerk did point out that this should be taken in context, as it is part of the risk assessment and it would mitigate the risk of aggression towards Councillors. Also, that the Risk Assessment will be a dynamic document and should be reviewed at least once a year.

Relevant training will be set up with the possibility of the Officers setting up a roleplaying scenario for Councillors.

We may need to consider a booking appointment system
